The managing partners of Ponoi II LLC may be deemed to have voting and investment power with respect to such shares. Each individual managing partner disclaims beneficial ownership of these shares, except to the extent of his pecuniary interest in such shares.
4. Consists of 4,428 shares of Common Stock held directly by Ponoi LP and 4,427 shares of Common Stock held directly by Ponoi II LP.
